# Refuse Companies Nationwide Switching to Trucks Fueled by CNG

There are nearly 180,000 refuse trucks operating in the U.S., burning approximately 1.2 billion gallons of diesel fuel per year, and releasing almost 27 billion pounds of greenhouse gases ( $CO_2$ ). Every gallon of diesel fuel burned emits more than 22 pounds of  $CO_2$ . In addition to contributing to global climate change, diesel-fueled trash trucks pose a health threat to city populations from both harmful emissions and engine noise. These problems can be reduced or eliminated by switching to trucks fueled by compressed natural gas (CNG):

- Particulate matter is reduced by 67% to 94%
- Nitrogen oxides (NOx) are reduced by 32% to 73%
- Non-methane hydrocarbons are reduced by 69% to 83%
- Carbon emissions are reduced by 20%
- Noise in decibels is decreased by 50% (behind), 90% (inside), and 98% (beside)
- Water pollution in the form of organics is eliminated

or liquefied natural gas (LNG). California leads the way with the help of the South Coast Air Quality Management District, who mandated the switch to all CNG refuse trucks by 2020. Culver City, California was one of the first municipalities to replace CNG refuse trucks with new CNG vehicles. Other states have similar mandates, including Texas, New York, Georgia, and Florida.

### **Other Benefits**

Though the price for a natural gas truck is \$30,000 to \$50,000 higher than a diesel truck, the higher cost is offset by both lower fuel costs and maintenance costs (fewer oil changes, no particulate filters, less carbon buildup). In one case, fewer oil changes resulted in savings of \$400 to \$800 per truck annually. Other advantages include a healthier environment for drivers (no diesel emissions or fumes) and trucks are more reliable than those that run on diesel.

Natural gas prices range from \$1.50 to \$2 per gallon equivalent, while diesel fuel is typically over \$3 per gallon. According to the January 2012 Clean Cities Alternative Fuel Price Report, the average price for diesel and CNG was \$3.86 and \$2.13, respectively. The U.S. Energy Information Administration predicts, as of March 6, 2012, the average retail price of on-highway diesel fuel for March through December 2012 is \$3.92 per gallon, and the average for 2013 is \$4.11 per gallon. One company saves about \$1,000 a month in fuel costs per truck over a diesel.

There are also economic incentives available for natural gas use. Natural gas can be purchased with long-term supply contracts, insulating large fleets from market fuel price volatility and ensuring more consistent operating costs. Natural gas is also taxed at a lower rate than diesel in many states.

There is a wide range of natural gas trucks to choose from since all major refuse truck manufacturers now offer natural gas. Engine technology continues to improve, with performance regarding low-end torque equal to or better than diesel. A new 400-hp engine under development has 1,450 ft-lbs of torque that requires a single fuel source and can run on either CNG or LNG. CNG tanks have also been introduced that maximize on-board storage capacity for greater driving range.

### **Conversion Continues**

In 2011, a milestone was reached when Waste Management rolled out its 1,000th natural gas truck. Smithtown, New York was the first community outside of California to have 100% of its garbage truck fleet converted to CNG and now Long Island has 100 CNG trucks. More recent activity continues east of the Mississippi:

- Chesapeake, Virginia is converting its fleet of 53 trucks to CNG, which will save the City \$14,000 per year and more than \$740,000 in annual fuel costs when the entire fleet is converted.
- Waste Management is converting its 55 garbage trucks in Columbus, Ohio, which will be the company's first fleet of CNG trucks in that state. The company also opened a re-fueling station in West Seneca, New York for its own fleet of trucks.
- Columbus, Ohio has built the largest fast-fill CNG fueling station in the Midwest and has 23 dedicated, heavy-duty CNG vehicles in operation.
- With a \$194,076 grant from the Carolina Blue Skies and Green Jobs Initiative, Charlotte, North Carolina is adding four CNG trucks to its refuse fleet.
- Pomona, California purchased 22 CNG refuse trucks, replacing its entire diesel refuse truck fleet, with the help of the California Energy Commission.
- Rumpke of Ohio invested \$2.3 million and partnered with Clean Fuels Ohio to obtain an \$800,000 grant to purchase 10 (CNG) trucks and construct a fueling station in Southwest Ohio.
- With a \$500,000 grant from the Pennsylvania Energy Development Authority, Pittsburgh is purchasing four CNG trucks, which will reduce the city's operating costs by nearly \$40,000 per year.
- Beverly Hills, California already purchased two CNG trash trucks and four CNG street sweepers. The City Council recently authorized nearly \$667,000 for two additional CNG trucks.
- The City of San Antonio Solid Waste Management Department operates the largest CNG powered fleet of refuse trucks in Texas.

- Montgomery County is the first in Maryland to convert its 100-truck trash and recycling fleet to CNG vehicles.
- The New Jersey Clean Cities Council is helping to convert five trash collection fleets to CNG and is building six CNG stations.
- Choice Environmental has 14 CNG collection trucks operating in Broward County, Florida and is replacing the 30 remaining diesel trucks at Pompano Beach, Florida with CNG vehicles.

### Regulatory & Code Update

Issued May 1, 2012 - PHMSA is issuing an Advisory Bulletin to remind operators of gas and hazardous liquid pipeline facilities to verify their records relating to operating specifications for maximum allowable operating pressure (MAOP) required by 49 CFR 192.517 and maximum operating pressure (MOP) required by 49 CFR 195.310. This Advisory Bulletin informs gas operators of anticipated changes in annual reporting requirements to document the confirmation of MAOP, how they will be required to report total mileage and mileage with adequate records, when they must report, and what PHMSA considers an adequate record. In addition, this Advisory Bulletin informs hazardous liquid operators of adequate records for the confirmation of MOP.

### Louisiana's Dig Law Has Changed

Late last year Governor Jindal signed into law significant changes in the Louisiana Underground Utilities and Facilities Damage Prevention Act R.S. 40:1749, otherwise known as the state's "dig law." These changes affect everyone involved in excavation in Louisiana, including homeowners, contractors and utility operators.

### **Waiting Period Changed**

Under the revised statute, utilities, pipelines and other operators will have a little more time to mark their underground facilities. The waiting period is now two full business days beginning at 7 a.m. on the next working day after the excavator files their request to have the site marked.

### **Emergency Excavations Redefined**

The revised law now defines emergencies more strictly. The new definition requires that excavators who declare an emergency must have a crew on site when an emergency is declared, and provides for penalties up to \$5,000 for repeated violations of this requirement.

#### Markings Valid Longer

Once the site is marked, the markings are considered valid so long as they are visible <u>for up to 20 calendar days</u> on non-agricultural sites, doubling the time allowed before such sites must be marked again. Farmers and other agricultural excavators get an additional 10 days and therefore need not request re-marking for 30 days so long as the marks remain visible.

### More Time to Plan Large Jobs

Excavators working on large projects may now request utility location up to 20 days in advance.

### **Utility Operators May Elect Not to Receive Notifications**

Finally, the new law will allow utility operators excavating near their own underground systems to elect not to receive notifications involving their own work.

Now and always, call before you dig. Wait for the site to be marked. Respect the marks, and dig with care.

### Mechanical Fittings Failure Reports

On June 11, PHMSA published in the Federal Register an Advisory Bulletin to provide clarification to owners and operators of gas distribution pipeline facilities when completing the Mechanical Fitting Failure Report Form, PHMSA F 7100.1-2. Initial reviews of reports submitted for calendar year 2011 failures have identified a need for PHMSA to issue this notice to provide operators with additional guidance for reporting the apparent cause. PHMSA has also enhanced the online submittal process and plans to implement further improvements.

The meeting will also include panel and breakout session discussions involving gas distribution pipeline industry representatives on topics relating to their experiences implementing the distribution integrity management regulation.
