Pipeline Safety Update by Sue Guidry

Everywhere you look these days it seems that many of our regulations for the oil and gas industry are undergoing intense scrutiny. This article deals with recent Advisory Bulletins (ADB) issued by the Pipeline and Hazardous Materials Safety Administration (PHMSA), and National Pipeline Mapping System (NPMS) Operator Standards Submission Guidance.

PHMSA uses Advisory Bulletins as a means of communicating with operators on issues that have been found through incidents or accidents, releases, investigations or inspections. Many of these advisory bulletins can serve as a means of giving operators a focus for improvement efforts in their programs. They can also be used as a tool for alerting operators of potential problems with equipment or materials, or even weather related damages that may occur due to flooding or hurricanes.

At the beginning of 2014, PHMSA issued ADB-2014-01 pertaining to conforming Facility Response Plans (FRP's) to Appendix A of Part 194. The bulletin was issued as a reminder that all FRP's need to be updated every five (5) years from the date of last submission or the last approval according to its significant and substantial designation. Plans must also be updated whenever new or different operating conditions would affect the implementation of a response plan. When updating FRP's operators should utilize Appendix A Part 194 - Guidelines for the Preparation of Response Plans and submit them electronically to PHMSA.

ADB-2014-02 focuses on Integrity Management Lessons Learned from the Marshall, Michigan, Release. PHMSA issued this ADB to notify pipeline owners and operators they should evaluate their safety programs and implement any changes to eliminate

deficiencies similar to the ones the National Transportation Safety Board (NTSB) found when it investigated Enbridge's July 25, 2010, crude oil release in Marshall, Michigan.

Specifically, the NTSB investigation identified deficiencies in three Enbridge programs: Integrity Management (IM), control center operations and public awareness. The NTSB noted that had existing regulations, guidance, advisories and recommendations regarding these programs been properly acted upon, the consequences of the incident could have been prevented, or at the very least, mitigated.

As with most ADB's, PHMSA strongly encourages operators to review past and future NTSB recommendations that the NTSB provides to pipeline operators following incident investigations. Operators should proactively implement improvements to their pipeline safety programs based on these observations and recommendations so that the entire industry can benefit from them.

The National Pipeline Mapping System (NPMS) consists of geospatial data, attribute data, public contact information, and metadata pertaining to interstate and intrastate hazardous liquids trunklines and hazardous liquid low-stress lines as well as gas transmission pipelines, LNG plants, and hazardous liquid breakout tanks regulated by PHMSA.

Effective May, 2014, the NPMS Operator Standards for Pipeline, Liquefied Natural Gas and Breakout Tank Submissions, was updated to include the following changes:

- Section 1.1 regarding abandoned pipelines was clarified to specifically include gas pipelines, in addition to liquid pipelines.
- A note was added to the COMMODITY attribute description in the Pipeline Attribute Table to clarify when to use the commodity code EPL and EPG.
- Appendix B Abandonment Certification Template (typo correction made)

Operators insure the location, line size and commodity in the pipeline are reported accurately. NPMS data is available to anyone through the public viewer and provides information regarding the pipeline and contact information to any interested party. **Click here for more information.**

Legislative Update

House Bill 868 was signed by Governor Jindal and will take effect on August 1, 2014. The signed Bill became Act 203 and includes four items. The first is the delayed marking; this is allowed when there is a documented agreement between the owner/operator and the excavator. Second is offset markings. Third is warning letter for the first citation. And fourth are changes to the penalty section of the law concerning hazardous and non-hazardous materials.

PHMSA will conduct an interview regarding the "Nine Elements Damage Prevention Study." It is anticipated that the interview will take place in July. Anyone interested in details may want to contact David Frey.
