NGV Incentives

The Louisiana Gas Association and several groups participated in the past few months in an effort to maintain the Alternative Fuel Tax Credit in Louisiana. 13 bills were filed to sunset or reduce the tax credit. In the end 2 bills were passed and both keep the tax credit while reducing the benefit. These tax credits are needed to help defer the NGV first cost and infrastructure. Thanks to all who helped to keep this valuable benefit.

CNG School Bus Vison Tour - LA

The week of April 17, Blue Bird Bus partnered with Ivan Smith Furniture, Louisiana Gas Association, Town of Hornbeck and Louisiana Clean Fuels to bring a CNG School Bus to Louisiana for events in Shreveport, Leesville and Baton Rouge (Odyssey Day). The goal of bringing the bus to Louisiana was to educate school systems that the CNG School Bus is available and how well it operates with the VW settlement dollars targeting school buses in LA. We had school systems at each event and



demonstrated the bus with a drive and ride. At Odyssey Day in Baton Rouge, Dr. Brown, Director of the Louisiana Department of Environmental Quality (DEQ), spoke and discussed how the VW settlement will be used for School Bus replacement in Louisiana. DEQ will be the administrator for the VW Settlement in LA.



NGV National Road Rally

On June 7 Louisiana Gas Association partnered with the American Gas Association and NGV America to conduct the Drive Natural Gas Road Rally and Leesville was the Louisiana stop. The Leesville event was hosted by CNP, Louisiana Gas Association, Town of Hornbeck and Louisiana Clean Fuels.

Media coverage was gained local media coverage from Alexandria's NBC 6 news and Leesville Leader Newspaper. The event was kicked off at 10 am with an interview of drivers and the Town of Hornbeck and Geaux American, Clarence Beebe, Louisiana Clean Fuels, Ann Shaneyfelt, and NGV Solutions, Kent Meadows. We had 15 NGVs fueled and staged at the station, ranging from light duty trucks cars and delivery, refuse, 18 wheeler.

LGA Legislative Updates

Sine Die: The 2017 Regular Session of the Louisiana Legislature adjourned Sine Die (final adjournment) June 8 at 6:00 pm. This brought to a close the sixth legislative session since Governor John Bel Edwards took office in January 2016. While the Regular Legislative Session is over, time for executive (Governor) action remains.

Special Session: The Governor called a Special Session to convene 30 minutes after the Regular Session in the circumstance that the House & Senate did not reach an agreement on the state's budget. Unfortunately, legislators were unable to hash out a budget during the final hours of the Regular Session, so the Second Special

Session of 2017 convened at 6:30 pm June 8.

Second Special Session: The Second Special Session is limited to measures pertaining to appropriations of the state's budgets, capital outlay, or bond authorization. The House began the budget process on Monday, June 12, and the Senate returned to the Capitol on Wednesday, June 14. The session adjourned June 19.
